Our Governors are drawn from various careers to ensure they have the skills to challenge and inform our direction. Meetings and actions have already taken place and will continue each half term. We are also advertising for a new teacher to increase senior leader capacity by 20%.

#### 2. Curriculum Development:

We are working diligently to develop and implement a comprehensive, well-structured curriculum that integrates formal classroom learning with practical applications. The planning for this is well advanced, with delivery projected to start in the new academic year.

#### 3. Health, Safety, and Record Keeping:
